



NCCC National News

Hi All,

I just got back from the national governors meetings in St. Louis, so here we go... As usual, in the order that I wrote it down.

Friday April 30, Membership Committee meeting:

Pat Kelly, Future Corvette Owners Association, reported that she has no way to track the FCOA members that turn 16 and then join NCCC as a Youth member. We're trying to find out if the new Youth membership category is actually being used. There was a suggestion to add some kind of check box on the membership application form for former FCOA members, but there is no room on the form for more text. More on that later...

Sylvia Hoaldridge, Blue Bars Magazine editor, said the deadline for articles for the next issue is May 31st. The issue will be published around July 1st, so articles should be applicable to the July and future time frame. She said the Spring issue is currently at the printer and will start going out soon. There has been a problem with the NCCC 50th anniversary picture insert. She was hoping to put it in the Summer issue but it turns out that the photographer sold the pictures to the web site that is hosting them. They are working to resolve that issue and the pictorial will show up as an insert in the center of the magazine that can be removed. She said the last hurdle to the USPS periodical rate will be handled when the local post office representatives make a site visit to her house on Tuesday. NCCC's official address is her house because she publishes the magazine from her home office. This should result in a 40 - 50% reduction in the postage to mail the magazine and NCCC also gets a credit on that amount for the issues that have already been mailed this year. This will save NCCC several thousand dollars per year. As part of the USPS requirements, NCCC had to add this to the applications: "Annual dues for membership in NCCC for the year 20 are \$35. \$10 of this amount is for a one-year subscription to Blue Bars." We have been asked to not use the older applications that don't have this verbiage. I don't know how they are going to enforce this. I still get applications that were printed as far back as 2004.

Larry Higgins, Distribution Center manager, said he mailed out 10,700 renewal packets. (Reading my notes, it's not clear if the following are part of that or in addition.) He said there were 1300 packets mailed to late renewers and 400 to new members. He said he has a big problem matching Primary and Spouse/Companion labels. The packets are mailed to the Primary's address and the labels are printed in member number order. Many times the spouse number is far away from the primary number and the last names are not the same so he has to match addresses. This takes a LOT of time. We're told that the new membership database will be able to handle this situation. He apologized for taking so much time to get the renewal packets out. He said it's really a two person job and he's been overwhelmed since his wife died last year. He said that after doing it for the second time he's learned a lot and it should go smoother in the future. He said he's gotten a lot of reguests for missing membership cards. He said they were in there when the envelopes went out. He showed us some returned envelopes where the bottom was partially ripped out. Apparently the machines at the post office abrade the bottom of the envelope and the card falls out.

Denny Morin, Membership's representative to the Finance Committee, reported that the 2010 budget is \$40K short, based on the projected member numbers that Larry Morrison provided (17,500 members). Also they have reduced the projected attendance at the Convention in West Palm Beach from 400 to 350. The estimated break even point for Convention is 320 people. He said the Finance Committee was recommending a dues increase of \$5 for each Primary. (My note: Denny is new to this position and doesn't know the history so he tends to make suggestions that have been tried in the past and didn't work.) In my opinion that will NOT happen, based on the past history of requests for dues increases. The governors just won't approve a dues increase. I pointed out that the "budget shortfall" happens every year, mainly because the budget is a guess and NCCC normally spends less than projected. We looked at possible ways to cut our expenses, but we're pretty much at a minimum now. It was pointed out that we will save some money because of the reduced postage for Blue Bars. We didn't take a formal vote, but everybody pretty much agreed that there was no point in presenting a dues increase to the governors because they would never agree to it.

Related to the above, Larry wants to change to a 4 year membership card. After much discussion that was voted down for multiple reasons. There

was a suggestion that we eliminate all the flyers and ads from the renewal packet. We're not sure if that is possible because the ads are supplied by our sponsors and there might be a contract that requires them. They are currently printed by the sponsors and sent to the Distribution Center for insertion into the packets. If the flyers were eliminated they could mail out the membership cards in a #10 envelope for 44 cents. We had looked into using a printable membership card that could be lifted off a carrier after printing the membership info. Larry Higgins said it's very time consuming to peel off the labels and put them on the backs of 17,000 membership cards. Anyway, it was found that the peel off cards would cost 55 cents each. I pointed out when this was proposed a while back that our membership card is a standard credit card format that is made by the billions and they should therefore be really cheap. They discovered that it only costs 26 cents to print the credit card type card. With the 44 cents postage and the cost of an envelope we should be able to mail out the membership cards for about \$1.00 per family. Remember the 10,700 packets from above...those cost 61 cents each in postage to mail and the envelopes are oversize to hold the flyers, which means we could save quite a bit by mailing just the cards.

A copy of the artwork for the 2011 membership card was passed around. It shows a new ZR-1 doing a burnout, with lots of smoke. There was universal agreement that this is a bad idea and they will redo the artwork. We have had numerous complaints that the perception of NCCC is that it is a racing organization, which really turns off the people who just want a social club to "drive and dine". Somebody complained that Blue Bars seems to be all about racing, which is not strictly true, but Sylvia's email address is "pinkvette@..", which refers to the color of her RACE CAR (there is a picture of it here:

< http://www.corvettesnccc.org/OfficersAppoint.htm >).

We had a request for the governors to check over their NCCC rosters to make sure the addresses of the primary and spouse/companion members match. As mentioned above, the new database will allow matching addresses but that only works if they are exactly the same. As I've said many times, computers have an IQ of zero, and if one address is, "123 Elm Street" and the other is "123 Elm St." then they DON'T match, as far as the computer is concerned.

Our esteemed VP of Membership said at the meeting in February that he would no longer allow "split memberships", where the Primary is a member of one club and the Spouse is a member of another club. As mentioned above, mailings from NCCC go to the Primary's address. If the membership is split, the two clubs might renew weeks apart and it is impossible to match up the address labels. Larry mentioned that the By-Laws might technically allow split memberships. They are looking into this and might change the wording in the By-Laws to clarify this.

Saturday, May 1st, National Governors Meeting:

President Dick Yanko started out the meeting by reading the deaths into the minutes. There were 12 since the meeting in February. This number is about 2 to 3 times what it was when I first started going to these meetings in 2003, and it keeps increasing as we age...

Larry Morrison, VP of Membership, reported that they hope to have the new membership database available before the Convention in July. Right now it is still in the testing phase and not the real one, so you can play with it without worrying about hurting anything. Based on reports I've heard from several governors, they will not be using it because they don't have the computer skills. That's OK. We still require the hard copy of the applications with the dues checks, even if you enter the info into the database.

Bernyce Molenda, NCCC Treasurer, talked about the financials. We have switched from a formal audit every other year to a "review" (whatever that is), which is a lot cheaper. They will still do an audit, but not as often. She mentioned that 100% of NCCC's income comes from dues. I told her later that that's not true because we also have the 50-50 raffle at the governors meetings, but she said she has never seen that money. Allen Morris told me that the money goes to Charity.

Our Parliamentarian mentioned that the Standing Rules are now on the main NCCC web site at http://www.corvettesnccc.org along with the By-Laws and Competition Manual.

Allen Morris asked me to leave insurance out of my report, but I think this is important so I'm going to say something anyway. There have been

changes in personnel at K&K and the new people are not familiar with the agreement K&K has with NCCC. Without going into details because this is not resolved yet, you need to send PRINTED COPIES of your newsletters to Allen. Many clubs are publishing their newsletters electronically nowadays, but the agreement with K&K requires a PRINTED copy. Make sure

your newsletter editors are sending those copies to Allen. I think there might be clubs that don't have newsletters. In that case you need to send a paper copy of your event flyers to Allen to make sure you have insurance coverage for your event. I think a printed copy of an email would qualify also. Another key item: mail it to Allen BEFORE the event.

I have "boring and uninteresting" in the margin of my notes. I have no idea what that means, so...

National Competition News

NCCC Competition Committee Minutes 4/30/10

Sheraton Westport Conference Center

St. Louis, MO.

Competition meeting Open Session began at 6:30 p.m. CST. Present were VPC Jack Wilson plus 13 RCDs and one proxy representing all 15 Regions, which were CA Johnny Haskell, EO Chuck Stephens, ER/NE Brian Gallagher, FL Manny Montgomery, IN Mike Godfrey, MI David Johnson, MW Paul Haack, RR Paul Hamersly, SE Don Parks, SW Joe Reese, WR Jerry Koraleski, WC Joe Orrico, WO George Cramer (proxy), and RM Rik Noring Jr.

Introductions:

RCD introductions were made and a welcome was extended to George Cramer as proxy RCD for WO. There was also a gallery of members present to witness the meeting.

VPC Comments:

Jack distributed all the 2009 Regional & WR #1 Club National patches.

High Speed and Novice cards were made available for distribution.

Jack reminded everyone that helmet expiration is based on the manufacturer's date identified inside the helmet, i.e. 9/00 means the helmet <u>expires</u> at the end of Sept. 2010 <u>not</u> at the end of the year. Those helmets <u>which only have</u> the manufactured year identified in them, i.e. 2000 will <u>expire</u> at the end of 2010.

The helmet manufactures, i.e. Simpson, Bell, etc. have stated the 2010 Snell Rated helmets will not be manufactured until October of 2010.

The issue with Impact Racing SFI rated products was discussed, and it does not impact Snell Rated helmets. It only affects suits, belts, shoes, gloves, etc. that are SFI rated.

There were seven (7) RCDs who identified they are planning on making it to the Florida Convention. All RCDs attending are asked to support the Florida Competition Program by working the Technical Inspection area. Denny Murphy is the Florida Chairperson in charge of Technical Inspection. Contact Denny as soon as you get there so you know where to go and what to do.

Meeting Minutes Approval:

Chuck Stephens made a motion to approve the Feb. 26, 2010 meeting minutes. Joe Orrico seconded. Motion carried.

2010 Sanctioned Event Status Review:

The 2010 Point Standings has been published 4/27/10 and put on the NCCC Website. Jack will identify the Top 5 Men, Ladies, and Clubs only at the Sat. Govs. Mtg. instead of the Top 15 since results has just started coming in.

Jack asked the RCDs to review their sanction log to ensure everything you think I should have received is entered. I have posted everything I have received.

Jack wanted to thank the RCDs for sending Sanction Requests & Flyers <u>separately</u>. This really helps to expedite entering them into the correct file when downloading. Also, it is greatly appreciated that you <u>stopped</u> entering the Region into the Sanction Number Column on Sanction Requests, i.e. MW-167-052. <u>Only enter</u> club and sanction number, i.e. 167-052. This has saved much time from having to delete the region from each line when loading into the Sanction Log.

2010 High Speed Driving Schools Approved: 5/7 WR at Tulsa, OK in conjunction with 13 H/S at Hallett 5/24 & 25 at Pocono Raceway, Pocono, PA. 6/26 at Summit Point, WV. 7/23 at Summit Point, WV.

Drag Records:

There are four scheduled 2010 Record Drags Scheduled so far: SW 5/30/10 Thunder Valley Raceway Park, Noble, OK. FL 7/29/10 Nat'l Convention, Palm Beach Gardens, FL. WR 10/9 Kearney Dragway, Kearney, NE. SW 10/17/10 Thunder Valley Raceway Park, Noble, OK.

Teardown equipment status was confirmed as all good and ready.

Manny Montgomery identified only NCCC helmet and seatbelt age requirements would be required at the Florida Convention. Those of you running in classes requiring chutes and/or safety equipment by NHRA know what is required by their rules. Long pants, long sleeve shirts, and closed toed shoes are required for the drags by everyone.

Clarification(s):

There were no clarifications submitted.

Old Business:

It was identified that the east coast group setting up the Teen Driving School has run into a legal issue with a person claiming they are copywriting her material and has put a stop on it. They are trying to work out the issues in hope to provide this valuable tool to our teens across the country.

The rulebook language re-write on Page 12.1 that was identified as missing to coincide with the 2010 Rulebook changes discussed at the Feb. meeting will be corrected by Jack in May.

Manny Montgomery identified they only have two people entered for Overall Competitor at the Florida Convention. They are husband and wife. Hopefully, more will enter.

Manny also identified only 249 have entered and need approximately 320 to break even. Everyone is asked to get as many people from your regions to the Florida Convention.

New Business:

Jack passed out his proposed 2011 Competition Budget. Although there are not many places to cut costs, it is obvious every organization will have to bite the bullet and make some serious cuts in 2011 in support of the diminishing NCCC Budget. The E-Board will be having some serious discussion on potential actions everyone will need to take to balance our future diminishing income and rising expenses. Any ideas are to be funneled to Jack ASAP.

There was a Lessons Learned discussion with a list of do's and don'ts that stimulated from an incident at a venue where an accident occurred (no injuries) a fence had to be replaced, the contract between the Host Club and the venue owner was not read or understood, finances were withheld by the Host Club without the venue owner approval, emergency equipment was not provided per the contractual agreement, and K&K Insurance or Hal Tumbleson (NCCC Bus. Manager) was not contacted for proper insurance coverage acceptable to the venue owner. It was identified that complacency sometimes sets in, and we assume everyone has done their job to ensure a venue is legally and safely complied with in advance of the venue. Unfortunately, the lack of attention to detail can put the Host Club, Chairpersons, and NCCC into an embarrassing, legal, and negative situation. Hal Tumbleson addressed the Competition Committee in support of this issue and answered questions regarding future handling of insurance specific items. Providing Lessons Learned as an agenda item in future meetings and the RCDs discussing those with their clubs can only help us remind one another what we must do to avoid these situations. The RCDs will begin discussing the Lessons Learned with their clubs effective immediately.

It was discussed the changing of an entrants class following the Drivers' Meeting and after Technical Inspection is closed is not prohibited if the car has not broken down. Any changing of classes during the period the Technical Inspection is open will require that car to be re-technical inspected. Discussion over what classification "M" or "N" to put the 2011 Z06 Carbon Limited Edition occurred. It was decided since the car has not been built to a point of seeing testing results or autocross performance, this subject would be tabled and re-discussed at the Sept. 10, 2010 Competition Mtg. There was a discussion over a sensitive but real issue with our entrants becoming older with health issues and/or past event incident/s. It has been asked if the Competition Committee would consider some sort of required physical examine certification for High Speed events such as done by other organizations, i.e. NASA, SCCA, etc. After much discussion, it was decided that we have had several individuals who have health/physical issues that have taken it on their own and stopped entering High Speed events. In some cases, individuals have decided to stop or suspend Low Speed events until their condition is such they believe they can compete safely. It is also believed that we all have a responsibility to ourselves; our family, event workers/participants/audience, and NCCC to ensure the maximum safe environment exist at all times. Therefore, if we witness someone who may be experiencing unusual tendencies at a venue, we have an obligation to them and everyone else to professionally approach them and/or the local event Chairperson/Regional Officer for resolution if necessary.

Following the break, the Committee went into Closed Session for Round Table Discussions: Note: Due to the general notes included into the minutes from the Competition Committee Meeting, does not intend or represent any agreed upon changes to the Competition Manual (Rulebook). Discussion items are described general in nature for membership awareness only.

Roundtable Discussion:

Several general discussion items occurred to assist clarification for consistency and decisions within the various regions.

2011 Rulebook Discussion Items:

1.

Committee- Current Rulebook Bonus Program: The current FTD Bonus Program implemented in 2009 is to be reviewed now after being in affect for one year. There are several options available:

Leave it as is.

Increase the number of entrants in a sub-group from 2 to 5 or some other number before the sub-group FTD kicks in.

Leave or change the Overall Men & Ladies FTD at 11 or to 10 and eliminate the 10 points for 2nd fastest and 9 points for 3rd fastest.

Eliminate sub-groups entirely and go back to individual classes for all classes.

Other

Action: The RCDs will take back to their region for input.

2. RM- Elimination of Fire Extinguisher Requirement:

Should the requirement for having a fire extinguisher for "Low Speed events only" be eliminated except for RP & RPAF classes?

Action: The RCDs will take back to their Region for input.

3.WC- New NCCC Time Trial Event Section 11:

Should a new Time Trial and HPDE (Track Day) event be developed per the proposal and drafts submitted by WC & RR into our Competition Program?

<u>Action:</u> The RCDs will take back to their Region for input.

1. MW- Sec. 2.7.1.8 Item 76 regarding exceptions for Prom and Prom programs.

There was discussion as to pursue changing the current language of "Strictly stock computer, sensors, accessories and connections except that any Prom or Prom program is allowed." to "Strictly stock computer, sensors, accessories, connections, PROM and other program memories."

Decision: Yes 0, No 14 not to pursue.

1. MI & FL- Sec. 1.2.2 Elimination of the 100 mile distance requirement between Non-Sanctioned and Sanctioned Events on the same day.

Decision: Yes 14 to eliminate, No 0

1. EO- Chapter 8, Sec. 8.1.2.5.1 who must be present at events to receive points.

Propose adding a new #4 language: "4. Event Chairperson, Co-Chairperson, Rallye Checker, Rallye Co-Checker, Concours Judges, and all other Workers MUST be at the event to receive points." Decision: Yes 11 to accept the proposed new language, No 3

1. RM- Sec. 1.3.10 reducing sanction request and flyer time to RCDs and VPC.

Propose changing the current requirement for sanction requests to the RCD from 70 days to 45 days and to the VPC from 50 to 40 days.

Also, change the current requirement for flyers to the RCD from 50 days to 45 days and leave the VPC at 35 days.

Decision: Yes 12 to accept the proposed change, No 2

1. WR- Sec. 2.7.1.8; Note 7 Intergenerational Switching

WR- Sec. 2.7.1.8; Note 19 Block Cylinder Head Bolt Pattern

Corvette Legends of Le Mans: Dick Thompson

Chevrolet to Salute Championship-Winning Corvette Racer at Laguna Seca ALMS

MONTEREY, Calif., May 13, 2010 – Dr. Dick Thompson, the championship-winning Corvette driver known as "The Flying Dentist," carried Corvette's performance message around the world. Chevrolet will salute Thompson as one of the Corvette Legends of Le Mans at the American Le Mans Series Monterey at Mazda Raceway Laguna Seca on May 21-22.

Thompson co-drove one of Briggs Cunningham's trio of Corvettes in the 1960 24 Hours of Le Mans in Corvette's first appearance in the world's biggest sports car race. He later became the first driver to win a race in the iconic Corvette Grand Sport, and served as a Chevrolet development driver and promotional spokesman for production Corvettes in the '60s.

Thompson will be reunited with the restored No. 2 Cunningham Corvette that he shared with Fred Windridge in Le Mans 50 years ago. The Thompson/Windridge Corvette retired at 20 hours, but the sister No. 3 Cunningham Corvette driven by John Fitch and Bob Grossman won the large displacement GT class and finished eighth overall. Corvette chief engineer Zora Arkus-Duntov accompanied the Corvettes to Le Mans as an advisor and was listed as a reserve driver by the Cunningham team.

"I enjoyed racing in Europe very much, and competing at Le Mans in 1960 was an unforgettable experience for me, and for the entire team," Thompson said. "Briggs Cunningham had the experience, and quite frankly the money, to put forth an effort that was second to none. We had support from Chevrolet, from Zora, and others. The cars were race prepared by Alfred Momo at his shop on Long Island. We knew going to Le Mans that the cars would be ready and we'd have a very real opportunity to win our class there."

The Corvettes were in near-stock trim, with larger gas tanks, quick-fill gas caps, magnesium wheels, oil coolers, driving lights, racing seats and heavy-duty suspension components among their limited modifications – an expression of Duntov's philosophy of using racing to develop high-performance components for future production vehicles.

"Our car was quite fast but the brakes were a problem, as they almost always were in those early years of Corvette racing," Thompson recalled. "And of course, we had those skinny little bias-ply tires. Our Corvettes were really not big cars, but to the average Frenchman, compared with what they were used to, they looked like great big cars. More than a few of them were rather shocked to see us running around at those fantastic speeds on the skinny tires we had."

When the 55 entries were lined up for the traditional Le Mans start according to engine displacement, the three Cunningham Corvettes occupied the first three spots with their 283-cubic-inch fuel-injected small-block V8s. A fourth Corvette entered by airline pilot Lucky Casner under the Camoradi USA banner rounded out the Corvette quartet.

"At Le Mans in those years they still did a running start," Thompson said. "All the drivers would line up opposite the cars on the front straight and when the signal was given we'd each run to our car. I managed to get away ahead of everyone, and going under the Dunlop Bridge I had nothing but open road in front of me, and the entire field behind me! That was quite an exciting feeling. Of course that didn't last, and the faster modifieds, the sports racers, managed to pass me."

Rain soon inundated the Le Mans circuit, and the drivers had to endure a cold and wet night on the pitch-black course through the French countryside.

"The Le Mans race was really a remarkable experience for me," Thompson remembered. "By 1960 I had done quite a bit of driving, at a lot of different tracks, but Le Mans was unique in many ways. It was particularly interesting at night. Sebring of course was quite dark at night, but at Le Mans it was a different feeling, a feeling of really being alone out there. The fog and the rain added to that sensation, the feeling that you're driving through the countryside as fast as you can possibly go, with nothing but the rain, the darkness, your car, and your courage!"

The No. 2 Corvette lost time when it was mired in one of the numerous sandpits that lined the circuit, and then the overtaxed engine expired in the 20th hour.

"It was the brakes, indirectly, that took our car out of the race," he said. "The engine failed in fairly dramatic fashion, but that was not because of a problem in the engine. The brakes gradually got worse and worse and we relied more and more on the downshifts to help slow the car. The engine had been over-revved by about 1,000 rpm on some of the downshifts, and this was recorded on the tell-tale tach, and it ultimately caused the engine to give up."

Cunningham drivers Fitch and Grossman continued to circle the immense circuit in the No. 3 Corvette, running as high as seventh overall. In the waning hours of the race, the engine overheated and lost coolant but regulations prohibited the team from refilling the radiator. Team manager Momo instructed the crew to pack the engine with ice from the team's catering tent. Driving at reduced speed, the ice-cooled Corvette finished first in the 4000-5000cc GT class and eighth overall – the best finish by a Corvette until the arrival of Corvette Racing four decades later.

Thompson's racing career is a chronicle of the early days of Corvettes in competition. A Corvette propelled him to the 1956 SCCA C-Production national championship, putting the world on notice that Corvette was a genuine contender against European sports cars. Thompson and his Corvette left their mark in the record book in 1957, earning a class victory at Sebring and another SCCA national title. The dentist from Washington, D.C. went on to win three more national championships driving Corvettes, including the C-Modified title with Bill Mitchell's Stingray Racer in 1960, B-Production in a Gulf Oilsponsored Corvette in 1961, and the A-Production crown in another Gulf Oil Corvette in 1962.

Thompson was one of a handful of racers who transformed Corvette's performance image at a crucial period in the car's history. He played a pivotal role in laying the foundation for success that Corvette has enjoyed on the street and on tracks around the world. Chevrolet is proud to salute the Flying Dentist as one of the Corvette Legends of Le Mans.
