
## Under The Radar

Charities, For many years, CSS has been a major sponsor for our two main Charities; H.I.S. House Transitional Shelter and CHiP's for Kids.

**HIS** House is a 4-6 month program for homeless men, women, and children to prepare for and secure employment, education and permanent housing.

CHiP's for Kids began with an individual CHP officer that spread like wildfire within their own departments. To reach out in the community to help abused, orphaned, and seriously neglected children. Corvette Super Sports was introduced to Hillview

Acres Children's Home though our involvement with the CHP. Hillview brings hope through a safe therapeutic environment, to help children regain trust, a place to heal and away from serious emotional disturbances.

Through our volunteer and club events such as car shows, visits, work/clean up day, donations, garage sales, Corvette Super Sports donated not only many hours throughout the year but also monetary donations. HIS House and CHiPs, combined, have been recipients of \$5000 each year. We hope that this will continue with our SUPERSPORTS member's efforts.





Hello Governors,

From the recent meetings in St. Louis...

Friday 2-25-2011, Membership Committee meeting.

Betty Parks, Convention treasurer told us she has received 440 registrations for Convention, so things are proceeding well there and it will be a good Convention.

Sylvia Hoaldridge, Blue Bars editor, said the database wasn't set up correctly and failed to produce mailing labels for the Charter and Lifetime members. They had to do an additional print run in order to deliver issues to these members. way, you can become a Lifetime member by paying \$300 at renewal time. You will receive a special membership card that shows you're a Lifetime member and you'll never pay NCCC dues again. The break even point is 12 years, so if you plan to live longer than that it might work out financially...

Larry HIggins, Distribution Center, said he mailed out 10,362 total packets (renewals plus new members). He said the postage for that was \$9198. He passed out packets that were returned for various reasons. I will be forwarding them to you to deliver to your members. We need updated addresses or corrections for whatever the problem is. In some cases these are a mystery. I have one packet that has the correct address on it. I was at this person's house in December, so I know it's correct and he lives there. It says, "Attempted - not known", so maybe he moved since then? (I don't think so.)

There has been a lot of emphasis lately on saving money. Part of this comes from the fact that NCCC is down about 1000 members from the highest number about five years ago. This means less income from dues. Expenses have increased since then, so we're trying to do the same things with less money. One aspect of this is that we've been asking for suggestions for increasing membership. Along the same lines, we're trying to promote NCCC and some people have questioned the methods. NCCC has two traveling displays that are sent to any club that asks for them. One of them was at the Corvette Dreamin' car show in San Diego the last couple of years and PR Director Doug McMahan told me they asked for it again this It costs about \$1500 per year. year to ship the displays around the country. I have asked in the past how many new members are brought into NCCC from the display. Nobody has been able to answer this question. suggested several years ago that we write "display" on the membership application forms, but that hasn't been done.

can't see that we get \$1500 worth of new members from the displays, especially since they are sent to events where most of the people there are already NCCC members. The display is set up at various non NCCC events, notably Corvettes at Carlisle and similar We were told that Chip events. Miller used to give NCCC free space to promote the charity raffle car and NCCC. After he died, his sons refused to do that. NCCC does get a lot of support from Mike Yaeger of Mid America Motorworks. Mike has been closely associated with NCCC since he started his business. He told us a few years ago that he used to come to the NCCC governors meeting and sell Corvette parts out of the back of his station wagon. Anyhow, he puts on the Funfest event, which is huge. The problem is that NCCC's display is lost in the crowd of vendors and we're trying to figure out how we can stand out from the crowd and get some traffic. charity raffle car is a draw because a lot of people are interested in buying a chance to win it. Somebody mentioned that they have found out through experience that if you aren't giving something away then people won't stop at your display. Somebody suggested "booth babes", but at our age we don't have anybody that qualifies for that position.

Since there has been a lot of suggestions for bringing new members and new clubs into NCCC, it occurred to me to look at how many clubs are FORMER NCCC clubs. My thinking was, how can

we convince new clubs that belonging to NCCC would be beneficial if we can't keep the have? I went through a list of NCCC members in the West Coast Region that the VP of Membership This list only goes gave to me. up to clubWC-518, so it's an old Also Roadrunner Region clubs were part of the West Coast Region before they split off and became a separate region, so the numbers aren't strictly correct. Anywho, we had a total of 52 clubs on the list (about 5 were Roadrunner). Out of those 52, 23 are still NCCC clubs. Some of the clubs are dead, but there are several that are still around, notably Santa Clarita and North County Corvettes. Some of those were NCCC clubs for many years, like Fresno. Why they left is a mystery as they never say why they're not renewing. Most people believe that the reason is that they don't see a return on their investment of the yearly dues. The biggest benefit is the insurance

On this theme of NCCC benefits, I recently bought some parts from Eckler's, which is a NCCC sponsor and they supposedly give a discount for NCCC members. I say "supposedly" because I ordered on their web site and I couldn't find a place anywhere in the ordering process to indicate that I'm a NCCC member and should get the discount. That made me wonder how to get the NCCC discount from the other sponsors that

offer it. I couldn't find this information anywhere. The main NCCC web site at http://www.corvettesnccc.org has an area right there on the first page that shows icons with links to various sponsors. hint on how to get the discount. Blue Bars Magazine has a list of sponsors that offer discounts, but the only info on how to actually GET the discount is "Contact Debbie Lindsay, Director of Sponsorship". It shouldn't be that hard. I didn't get a chance to talk to Debbie while in St. Louis so I don't know what's involved. I intend to pursue this. Stay tuned.

I've been told that we still need the white copy of the new member application form, at least until further notice. We were told that the USPS was given a list of new NCCC members and then asked for proof that those members knew that part of their dues was going to the Blue Bars Magazine subscription. did get approved for the Periodical Rate, but we're afraid the USPS might again ask for more proof that we deserve to keep getting that rate. send in those application forms. I will send out a separate email with a copy of the latest version of the form soon.

Walt Jenkins, NCCC database guru, told us that we need to pass on to the governors that they should click the "Submit Changes to RMD" button. When you do that I get an email telling me that you have made changes.

Without that click, my only indication that something happened is that I get a check in the mail. Then I have to go into your database screen and click the button to get the changes transferred over to my database screen so I can accept the changes and input the check Walt said this tracking info. has been such a problem that he's been thinking of eliminating that button because the governors aren't clicking it anyway. One suggestion that we hope will get implemented is to allow the dues info to be entered directly on the roster screen during renewals. way you wouldn't have to go back and forth between the roster screen and the member info I asked that a "Add screen. Spouse/Companion to this Primary" button be added so that you wouldn't have to look up or remember the Primary's number when adding a spouse. Walt said to be sure to check the "Inactive" members list to make sure that a "new" member wasn't actually a former member who is returning to NCCC. If you don't do that it can cause duplicated entries for the member, which confuses the database. Also, he asked that governors put in the member's middle initial to avoid too many people with the same name, which gets confusing.

Since the database has become our main way of tracking members the old methods which are described in the "Guidelines for Governors" booklet are completely obsolete. The booklet will be rewritten to update it so that it covers the current processes.

We spent quite a bit of time discussing ways of saving NCCC money and getting new members. Most of the suggestions were totally impractical and no real changes were made. The most popular target has been combining of regions. After the RMDs voted 12-3 to drop that issue, it's dead. Now they're looking at combining offices. I asked what the Parliamentarian actually does besides carry around a copy of "Roberts Rules of Order" in his pocket. I don't think this will go anywhere and I don't think the Membership Committee should be looking at this anyway.

I talked with Dennis Patrick, NCCC Merchandise, and he told me that the 2011 pins are available on the main NCCC web site. He told us in November that he would send out an email about the 2011 pins, but I never got anything. Several people have asked me about 2011 pins, so here ya go.

The governors will be voting on the location for the national governors meeting. I don't remember the exact years. think it's 2013-2015. You will be getting a ballot in the mail soon to vote on this. sites submitting bids were St. Louis (the present location) and Indianapolis. We were told that a web page will be set up to compare the costs, advantages, etc. for each location. main disadvantage we've seen is that there are no restaurants near the Indianapolis hotel, as opposed to many restaurants in the Westport complex in St.

Louis. We expect a very close vote on this and we REALLY want to continue going to St. Louis, so we will be asking you to vote for St. Louis. The main NCCC web site tracks the ballots as they are returned, so we will know who doesn't vote. We WILL bug you about this, so be proactive and get your ballot in.

We have a new insurance agent, Brown and Brown. Jim from B&B gave a presentation on the changes. The plan is to get this presentation up on the main NCCC web site soon. There were many changes, all of them good. Jim showed us pictures of his Fixed Roof Coupe (2002?), so he's "one of us" and understands the Corvette mentality and knows what we're concerned about. He said the first thing they looked at was the "extra" insurance coverage that many venues ask for. only covered \$1 million and many places want more than that. said the various clubs spent \$20,000 on additional coverage, as asked for by different venus. So they investigated this and found that the highest coverage any venue wanted was \$4 million. made NCCC's coverage \$5million. That's automatic for every NCCC club and every member. The \$5 million is for every NCCC "event", which includes competition and any event that the club participates in as a group, like a drive and dine. You are not covered while driving as an individual to a meeting place (your automobile policy covers that), but you are insured while part of the

group. B&B has added D&O (Directors and Officers), which we did not get from K&K. cover all the NCCC national officers, regional officers and club officers. So if your club is sued for whatever reason, the officers are covered and will have representation. K&K covered "track" vehicles (vehicles used at a competition event) with a \$1000 deductible. B&B changed that to \$zero deductible. B&B has also added "crime" insurance up to \$50,000 so if somebody absconds with your club treasury that's covered. Overall, this is a MUCH better deal than we got from K&K. One thing that did come up is coverage for spouses who are not NCCC members. are NOT covered, so if your non-NCCC wife is driving and something happens -- no coverage. It's got to be the cheapest insurance coverage there is at \$10 for \$5 million, so make those spouses NCCC members.

The deadline for articles for the next issue of Blue Bars Magazine is March 15th. If your newsletter had a good article that would be of general interest, go ahead and submit it

to Sylvia. Now that Blue Bars has de-emphasized racing and added more social articles you have a good chance of being published. I asked a while back why the drag records were in Blue Bars and everybody agreed with me that they should be moved to the NCCC web site. was surprised to see them in the latest issue. Well, it turns out that Sylvia wants those to stay in Blue Bars (her email is pinkvette@... Her RACE CAR is painted pink, so you can draw your own conclusions from Sylvia asked that you that). contact her if you haven't gotten your issue of Blue Bars. She said a bunch of the latest issue arrived with the guts missing (only the cover left).

A tentative bid for the 2013 Convention was received from Dick Yanko, former NCCC President and resident of Bowling Green, to have the Convention in Bowling Green. We'll see how that goes...

## From Long Beach to Le Mans: Corvette Racing's Overseas Odyssey

#### Le Mans Test Day Sets the Stage for Sports Car Racing's Main Event

**LE MANS, France, April 20, 2011** – This is only a test – but it's an important one. Corvette Racing will participate in the Le Mans Test Day on Easter Sunday, April 24. This one-day outing on the legendary French circuit will play a key role in the team's preparations for the 24 Hours of Le Mans on June 11-12, 2011.

"Every lap at Le Mans is valuable," said Corvette Racing program manager Doug Fehan. "It's impossible to test there outside of the race environment because the course uses several miles of public highway. When you have even one day to gather information it's extremely beneficial, especially when your competition is going to be there. Corvette Racing's objective is to maximize the value of our time on the Le Mans track and then apply that when we return for the race in June."

Once a fixture in the run-up to the 24-hour race, the stand-alone test day had been suspended for several years. Its return to the calendar in 2011 posed a logistical problem for teams competing in the American Le Mans Series, which hosted its second round in Long Beach, Calif., last Saturday.

"The schedule makes it difficult, expensive, and risky to get the cars and equipment from Long Beach to Le Mans in time for the test," said Corvette Racing team manager Gary Pratt. "Everything would have to be crated up and flown from LAX on Sunday morning after the ALMS race. Even a short delay in customs or air transport could mean that the shipment wouldn't arrive in time for the test.

"Fortunately one of our customers, Larbre Competition, has a Corvette C6.R that is available for the Le Mans test," Pratt explained. "This is a chassis that we ran last year in Le Mans, and that Larbre raced at Sebring last month. It's the same spec as our current cars and the Larbre team will compete with it in the GTE-Am class at Le Mans. Combining our resources for the test day and sharing the information that we gather will be a win-win for both organizations."

Corvette Racing's four full-season drivers – Tommy Milner, Olivier Beretta, Oliver Gavin, and Jan Magnussen – will attend the Le Mans test, along with key Corvette Racing personnel. At the top of the to-do list is the requirement to qualify Milner to race at Le Mans after a three-year absence. He went to the 24-hour classic in 2006 and 2007 with the Panoz team.

"I'm 25 years old, I've been to Le Mans twice, and yet it's been so long since I've raced there that I have to do 10 laps to qualify again to drive," Milner said with a laugh. "I'm looking at the test as a briefing on what it's like to drive at Le Mans in a Corvette C6.R. It will be a great opportunity to get comfortable in the car and to get seat time without the pressure of the race week." Olivier Beretta, Milner's full-season teammate, agreed: "It is very important to go to Le Mans when you have the rare opportunity to drive on the same track that you will race on," he said. "The only difference will be the weather, but Europe has been very warm recently and I hope the good weather will stay for another week. Then after the test we will have more time to think about and get ready for race week."

Driver Jan Magnussen will be reunited with an old friend at the Le Mans test day. "We'll be using my car from last year, so I should know it well," said the Dane. "The weather during April may not be representative of the conditions during the race, but the test is a opportunity for the drivers to get back into the rhythm of Le Mans. It is a different track to drive because you have to attack in certain places and not in other places, so it's helpful to get a few laps and work on the setup. Corvette Racing has always done a very good job of looking at all of the data and being right on when the race is there."

Oliver Gavin will be teamed with Magnussen at Le Mans this year, a combination that scored three consecutive GT1 class wins in 2004-06. "It's fantastic to be going to Le Mans because any time running on that track is precious," Gavin noted. "You've got to make the most of it because it's such a unique circuit and such a unique environment. It's great for Larbre Competition to work together with Corvette Racing. You think you've got loads of time with a full day to test, but it whizzes by so quickly. Each driver is keen to get as many laps as possible, and you've got to make the most of it. I'm sure the engineers will have a very detailed plan for every second of the test day."

## CORVETTE RACING TAKES SECOND AND FIFTH IN STREETS OF LONG BEACH

## Gavin and Magnussen Finish on GT Podium, Milner and Beretta Charge from Back of the Grid

**LONG BEACH, Calif., April 16, 2011** - Corvette Racing survived two hours of close combat to finish second and fifth in the American Le Mans Series at Long Beach. Jan Magnussen and Oliver Gavin took the second spot on the GT podium in the No. 4 Compuware Corvette C6.R when the race finished under caution. Tommy Milner and Olivier Beretta fought their way from the back of the grid at the start to fifth at the finish in the No. 3 Compuware Corvette C6.R. The BMW of Dirk Mueller and Joey Hand was first across the stripe under the yellow flag.

Not even Los Angeles' notorious rush hour could rival the traffic on the historic 1.968-mile, 11-turn temporary course. With 29 starters on the concrete-lined circuit, close calls and contact were commonplace, although only two full-course cautions slowed the race. Gavin started the No. 4 Corvette second on the GT grid and held that position through the opening segment, which was interrupted by a lengthy full-course caution. When racing resumed he took the lead with an opportunistic move.

"I had a very eventful stint with lots of bumping and banging and cars spinning in strange places," Gavin said. "The start was pretty standard, everyone got a bit strung out, and then the LMPC cars were getting in the way. It all started when the BMW behind me disappeared. On the next lap he was turned around at the fountain turn! The race leader went the wrong way, I went the right way, and I got myself into the lead."

Hand's BMW and Patrick Long's Porsche subsequently got around the Corvette, but Long soon encountered the wall and the Porsche eventually retired. As green-flag pit stops began shortly after the one-hour mark, Gavin handed off the No. 4 Corvette to Magnussen.

"I was pushing absolutely as hard as I could, and I was cutting the margin," said Magnussen, who ran the fastest lap of the race in GT and trimmed the BMW's lead to six seconds before the race-ending caution period. "There was a lot of traffic, and in a race like this you have to take so many chances. After the race I had a walk around the car and looked at all the places where I'd tapped the walls. It's a shame we weren't closer at the finish, we could

have had a good fight."

Milner was on a mission when the race began, moving from 14th in class to fourth before the pit stop sequence put Beretta behind the wheel of the No. 3 Corvette. The car was moved to the back of the grid at the start after a post-qualifying change of tires.

"I got lucky with the first yellow flag because we'd just cleared all of the Challenge cars and LMPC cars," Milner said. "The car was great, and although it was a little banged up, it was still quick. That's just street racing - everyone gets bunched up."

Beretta brought the No. 3 home in fifth after a relatively uneventful run. "I'm happy for the team - we got our second podium in two races which is really important," Beretta said. "Tommy did a good stint, he was very clever, and the car was quite fast. Then it was just using my brain to keep the position and put the points in the pocket."

Gavin and Magnussen are now second in the unofficial GT class points standings with 36 markers, and Beretta and Milner are third with 31. Mueller and Hand lead with 50 points.

"When you can leave Long Beach with two cars intact, you've accomplished something," said Corvette Racing program manager Doug Fehan. "The fact that we were able to finish second and fifth make this a very satisfying day. Now it's on to Le Mans!"

ESPN2 will televise coverage of the American Le Mans Series at Long Beach from 5 to 7 p.m. ET on Sunday, April 17.Corvette Racing's next event is the 24 Hours of Le Mans in Le Mans, France, on June 11-12, 2011.
