





A quorum was declared present by Secretary Bert Wiest.

Sergeant at arms Ron DeBartolomeis called the meeting to order at 1901 thanking all assembled for the cards and well wishes during his recuperation. Ron then led the assemblage in the Pledge of Allegiance.

President Tony Schavone welcomed all, thanking them for their attendance. He announced that the July meeting will be held on Wednesday, July 5th. He also reported that Patriots and Paws is in need of small appliances. The clean car award will begin again next month, change your clocks on Sunday.

Doug Utash, standing in for Wanda Utash accepted the regional NCCC award for first place, ladies car show.

#### Regional Membership Director's Message February 28, 2017

Hi Governors,

Since we have new governors this year, here is an introduction...

Allen Morris (Regional Executive), Joe Orrico (Regional Competition Director) and I (Regional Membership Director) go to St. Louis, MO for the national NCCC meetings 4 times a year. We have job-specific meetings on Friday night and the national governors meeting on Saturday afternoon.

As usual, in the order I wrote it down (more or less)...

#### Friday, February 24. Membership Committee meeting.

We had 19188 NCCC members at the beginning of renewals (October 14th, 2016) and 17669 members at the end of renewals (December 15th). We normally lose about 20% of our members during the renewal process and about 10% renew late. We lost 8 clubs during the renewal process. None of those are from the West Coast or North West regions. We did gain one club in the West Coast Region, Corvettes of Bakersfield.

10958 renewal packets were mailed out and the last of them went out by the end of January.

We have a problem with split memberships (the Primary and Spouse are in different clubs). Since the clubs don't renew at the same time, it is very difficult to match up the Primary and Spouse. Theoretically all mailings go to the Primary member but with a split membership the mailing to the Spouse must be mailed separately.

There is a place in the NCCC membership database for the clubs to add their mailing address. When you log in to the main menu there is a button, "Update Club Information". Click that button and you will see editable fields to enter your club's info.

In the future it will be possible to print your own membership card on the national NCCC web site.

We finished 2016 with about \$16,500 surplus.

We project to finish 2017 about \$17,000 ahead, thanks to the cost savings that have been implemented.

Enthusiast members are covered by the NCCC liability insurance.

It is suggested that each club print the club number on the club checks. This makes it easier for the NCCC Treasurer to track where the money is coming from.

I received about 20 renewal packets that had been returned by the US Postal Service because of address problems. Governors are asked to keep their members' addresses up to date so this doesn't happen in the future. This also affects Blue Bars Magazine because the mailing addresses are taken from the database. I will be mailing these returned packets to the appropriate governors and you are asked to update the membership database with correct addresses.



























#### RMD's Message (Con't)

#### Saturday, February 25. National Governors meeting.

We were told that an unnamed person claimed that NCCC did not donate any money to NKF (National Kidney Foundation). Treasurer Betty Parks went through the check register that was kept by Patrick Dolan (the former Charity Director). She found that NCCC donated slightly less than \$750,000 since the early 1990s when the Charity program was begun.

It was mentioned that only 3 clubs have submitted newsletters to the newsletter contest (Corvettes of Temecula Valley is one), which means the chances of winning are very good. The rules are online at the main NCCC web site (http://www.corvettesnccc.org).

We need accurate email addresses for all the members so that President Dave Heinemann's monthly message gets to everybody. IT Director Walt Jenkins said our "reputation" online is lowered by email bounces due to bad addresses.

There is a club web site contest. See the rules online at the main NCCC web site.

540 people have registered for the NCCC Convention in Bowling Green. There was some concern because some people have made room reservations but did not register for any Convention events. They thought that the non-registered people were taking rooms from people who will go to participate. When I called to make a reservation I was told that all the rooms had been taken. I asked how much it would cost for a room outside the NCCC block. The answer was \$889 for one night. I looked up the Holiday Inn on Expedia for Sunday night and the price was \$900. Apparently the hotels are taking advantage of the demand for rooms because of the total eclipse of the sun that will occur on Monday of Convention week. Some tours still have openings. All the high speed and low speed slots are taken (since then I was informed that the number of runs has been expanded and now everybody on the waiting list will be accommodated).

Director of Sponsorship Debbie Lindsey said that the Eckler's calendar has a discount code in every month.

If an FCOA kid moves fill out the address change form on the main web site.

We now have over 1000 NCCC members on the NCCC members-only Facebook page.

I was considering not writing this message to you because you will get the full minutes of all the St. Louis meetings from the NCCC Secretary in a few weeks. Allen said my "Reader's Digest" version would be read whereas the full minutes would not, so I decided to go ahead and write this.

That's all for now. Comments and suggestions welcome.

#### Where You Can Find Corvette Parts and Merchandise

For those of you who have been into Corvettes for awhile most – or all – of the following will not be news to you, but for you relative newcomers to the love of Vettes this offering is being made to help you find the parts you may need for your classic or the trim add-ons you might want to buy to personalize your Vette or the clothing, gear, etc. you might like to own to show others of your interest in the sport.

It's amazing just how many publications are out there that are dedicated to Corvettes and how helpful many of them can be. Following is a list and quick summary of the more popular catalogs that you might want to look into. Most of them are available for routine periodic mailing if you request it, and most of them have a web site from which you can peruse their offerings. Me, I prefer to receive the catalogs so that I can better see just what's out there I might not have not seen before.

The three largest, most popular catalogs with the most items that are non-"parts" are:

- a. Mid America Motorworks, <u>www.mamotorworkscom</u>, (800) 500-1500;
- b. Eckler's Corvette, www.ecklersCorvette.com, (800) 327-4868;
- c. Corvette America, www.CorvetteAmerica.com, (800) 458-3475.

Those publications periodically also publish catalogs geared specifically for a single generation of Corvettes so when they ask you for the year and model you drive don't be afraid to tell them.

Then there are catalogs that are almost exclusively for parts, especially of older model Corvettes:

- a. Volunteer Vette Products, www.volvette.com, (865) 521-9100;
- b. J & D Corvette, www.jdcorvette.com, (800) 838-8353 (located locally in Bellflower, CA).

For trim and accessory items as well as clothes, furniture and the like, you should look at:

- a. Corvette Central, www.CorvetteCentral.com, (800) 345-4122. They have an accessories catalog and a separate catalog of parts, etc., for each generation of Corvettes.
- b. Burston Marketing's Corvette Collection, www.CorvetteCollection.com, (800) 653-1375.
- c. And finally, the catalog from the retail store at the National Corvette Museum, www.CorvetteMuseum.org, (800) 538-3883.

In addition to the above, you might also consider visiting the show rooms of Corvette Mike's at 1133 North Tustin Avenue and West Coast Corvettes, 1210 N. Kraemer Blvd., both are located near each other in Anaheim just off the 91 freeway in Anaheim. They have a selection of GM authorized accessories and clothes for sale, as well as an indoor Corvette sales room with used road gems. Both also maintain service departments for installing accessories and the like and for general maintenance of Corvettes. West Coast Corvettes has a new catalog that was just released and is available for pick-up at the store. (Price is pre-printed on each catalog as \$12.95, but don't be fooled, they're free - just ask for one.)






















