## President Tony

It was 1953 – Elizabeth was crowned Queen of England at the age of 27, General Eisenhower became the 34<sup>th</sup> President of the United States and the first Corvette came out – being the first

sports car America could call their own.

This last event almost didn't happen. Chevrolet (along with most of Detroit) refuted the foreign invasion. GM got "cold feet" and took a hands-off attitude toward the Corvette. But then the father of it all, Arkus Duntov, offered to buy his bosses out and produce the Corvette himself. That made Chevy have second thoughts and gave him a second chance.

The Corvette came out at the Motorama Show at the Waldorf Astoria in New York. Its name derived from a convoy escort of WWII. The convoy's vessel was thought to be fast, daring and facile but in fact slow, dull and dormant. However, it sounded good. The sport car enthusiasts fell for it by the thousands. The first models were dull and slow, but the image was there. It began when they dropped Chevrolet's new V-8 engine under the hood and the development of fuel injection produced 283 horsepower – double the 1953 output.

The Vette had it made until Ford interrupted it with the Thunderbird. The T-Bird had the magic! America went for it, but the "bird" lost all sense of proportion. It grew 2 more seats and went out of the sports car category.

The raindrops came in the Corvette in 1953, but the Vette was sealed up in 1956. The road battles it, the back is kind of blind and the noises came out of nowhere, but it is ours and we love it! It is a legend. We applaud it and collect it. It is Americana, like apple pie and the 4<sup>th</sup> of July.

## RMD's Message

**May 7, 2018**

Hi Governors,

Since we have a new governor (Steve Thomas of Bridge City Corvette Club), here is an introduction...

Allen Morris (Regional Executive), Joe Orrico (Regional Competition Director) and I (Regional Membership Director) go to St. Louis, MO for the national NCCC meetings 4 times a year. We have job-specific meetings on Friday night and the national governors meeting on Saturday afternoon. In some cases, things discussed at the Membership Committee meeting were also discussed at the governors meeting, so there is some duplication of information. This is the "Cliff's Notes" version. The full minutes will be emailed in a few weeks by the NCCC Secretary.

As usual, in the order I wrote it down (more or less — some editing might have been done).

### **Friday, May 4. Membership Committee meeting.**

Everyone should have gotten a 2018 NCCC membership card. 17,000 were mailed and about 100 were returned because of bad addresses.

411 people have signed up for the New Orleans Convention.

The raffle car was cancelled due to lack of participation. Refunds are now being made. Many people have donated their money to St. Jude.

We need the date lifetime members joined NCCC. That date is put on the card.

The date that clubs joined NCCC is on the club info page.

### **Saturday, May 5. National Governors meeting.**

NCCC budgeted \$19,000 for the 2018 membership cards.

NKF has been paid completely. All funds earmarked for them have been forwarded to NKF.

The insurance FAQs are being updated and the new version will be posted soon.

The 2018 Convention is progressing nicely.

The 2019 Convention is also progressing nicely.

The 2020 Convention will be in the Indiana Region and is in the planning stages. Organization of the events is ongoing.

The REs are looking at the Standing Rules. The revised Standing Rules will be presented in September and voted on by the governors during the usual voting process starting in October.

Blue Bars Magazine will be mailed later this week.

The 2018 Convention in New Orleans has over 400 people registered. The hotel still has rooms available.

Offices to be voted on later this year are: President, VP of Membership, Public Relations, Parliamentarian and Treasurer. If you are interested in running for any of these positions, see the main NCCC web site for job descriptions, etc.

For those of you who have been into Corvettes for awhile most – or all – of the following will not be news to you, but for you relative newcomers to the love of Vettes this offering is being made to help you find the parts you may need for your classic or the trim add-ons you might want to buy to personalize your Vette or the clothing, gear, etc. you might like to own to show others of your interest in the sport.

It's amazing just how many publications are out there that are dedicated to Corvettes and how helpful many of them can be. Following is a list and quick summary of the more popular catalogs that you might want to look into. Most of them are available for routine periodic mailing if you request it, and most of them have a web site from which you can peruse their offerings. Me, I prefer to receive the catalogs so that I can better see just what's out there I might not have not seen before.

The three largest, most popular catalogs with the most items that are non-"parts" are:

Those publications periodically also publish catalogs geared specifically for a single generation of Corvettes so when they ask you for the year and model you drive don't be afraid to tell them.

Then there are catalogs that are almost exclusively for parts, especially of older model Corvettes:

For trim and accessory items as well as clothes, furniture and the like, you should look at:

- a. Corvette Central, [www.CorvetteCentral.com](http://www.CorvetteCentral.com), (800) 345-4122. They have an accessories catalog and a separate catalog of parts, etc., for each generation of Corvettes.
- b. Burston Marketing's Corvette Collection, [www.CorvetteCollection.com](http://www.CorvetteCollection.com), (800) 653-1375.
- c. And finally, the catalog from the retail store at the National Corvette Museum, [www.CorvetteMuseum.org](http://www.CorvetteMuseum.org), (800) 538-3883.

In addition to the above, you might also consider visiting the show rooms of Corvette Mike's at 1133 North Tustin Avenue and West Coast Corvettes, 1210 N. Kraemer Blvd., both are located near each other in Anaheim just off the 91 freeway in Anaheim. They have a selection of GM authorized accessories and clothes for sale, as well as an indoor Corvette sales room with used road gems. Both also maintain service departments for installing accessories and the like and for general maintenance of Corvettes. West Coast Corvettes has a new catalog that was just released and is available for pick-up at the store. (Price is pre-printed on each catalog as \$12.95, but don't be fooled, they're free - just ask for one.)
